Please note:

- 1. "Independent expenditure" is defined in Ark. Code Ann. § 7-6-201(11) to mean an expenditure which is not a contribution and expressly advocates the election or defeat of a clearly identified candidate for office, is made without arrangement, cooperation, or consultation between a candidate or an authorized committee or agent of the candidate and the person making the expenditure or an authorized agent of that person, and is not made in concert with or at the request or suggestion of a candidate or an authorized committee or agent of the candidate.
- 2. Act 753, Arkansas 94th General Assembly, Reg. Session 2023 (eff. August 1, 2023) amended Ark. Code Ann. § 7-6-220(a) to require that a person who or an independent expenditure committee that makes independent expenditures in an aggregate amount or value in excess of two hundred dollars (\$200) in a calendar year file reports with the Secretary of State.
- 3. "Independent expenditure committee" is defined in Ark. Code Ann. § 7-6-201(12) to mean any person that receives contributions from one (1) or more persons in order to make an independent expenditure and is registered pursuant to Ark. Code Ann. § 7-6-227 prior to making expenditures. Ark. Code Ann. § 7-6-227 requires that an independent expenditure committee register with the Secretary of State within fifteen (15) days after accepting contributions that exceed five hundred dollars (\$500) in the aggregate during a calendar year. Registration is annually renewed by January 15th unless the independent expenditure committee has ceased to exist.
