## Please note:

- 1. Exploratory Committee Registration: An exploratory committee is required to register with the appropriate filing office within fifteen (15) days after receiving contributions during a calendar year which, in the aggregate, exceed five hundred dollars (\$500). For a state or district office, registration shall be filed with the Secretary of State's office. For a county, municipal, township, or school district office, registration shall be filed with the county clerk's office. Ark. Code Ann. § 7-6-216(a)(1) thru (2).
- 2. Exploratory Committee Monthly C&E Report: In accordance with Act 592 (95<sup>th</sup> General Assembly, 2025 regular session), beginning August 5, 2025, an exploratory committee is required to file C&E Reports within twenty (20) days after the end of each month. Ark. Code Ann. § 7-6-216(c) (Supp. 2025). Pursuant to Ark. Code Ann. § 7-6-216(d)(1)(B), exploratory committee C&E Reports are required to be filed in electronic form through the official website of the Secretary of State's office.
- 3. Exploratory Committee Final C&E Report: A final report is required to be filed within thirty (30) days after the end of the month in which the exploratory committee either transfers its contributions to a candidate's campaign or no longer accepts contributions. Ark. Code Ann. § 7-6-216(d)(1)(A).
